

### Letter from the Executive Director.

As ORCBC continues to develop and progress in response to changing needs and opportunities within the organized recreation sector and society as a whole, it is rewarding to look back at the past year and celebrate our successes. I encourage you to read on to learn of some of the important highlights this year.

Our membership number soared to 70 as we welcomed 13 new member organizations on board, including Summit Trail Makers Society in Invermere, Prince George ATV Club and Mountain Bikers of the Central Okanagan.

We provided our members with opportunities to network and share resources through monthly roundtable discussions. Together, we explored topics such as reconciliation with Indigenous Peoples, partnership agreements, fundraising, and we received updates from the provincial leads within government on the trails strategy for BC and the new outdoor recreation strategy. We released insights from an Ipsos poll on the participation of British Columbians in outdoor recreation and their opinions on the benefits, barriers, and government's role in the development, and funding of recreation amenities.

The celebration of the 2022 BC Trails Day was a huge success, with 54 events in 46 communities and \$7,600 in small grants distributed to 20 event host organizations

Our fall/winter advocacy campaign concluded with 600 emails sent to the Minister of Finance and local MLAs, several meetings with ministers and parliamentary secretaries and a letter to Premier Eby from a coalition of 40 organizations and businesses representing the interests of the recreation and tourism sectors in B.C, calling on the B.C. Government to increase public spending in the 2023 provincial budget to support the outdoor sector and B.C communities. We saw budget uplifts for outdoor recreation and a \$10 million endowment for more support for community-based recreation groups.

Our persistent advocacy efforts are making a difference, and our successes have only increased our appetite for the work that lies ahead to ensure improved recreation opportunities for all British Columbians.

On behalf of the ORCBC staff team, I sincerely thank our members, directors, partners, funders and supporters for all your generous contributions of time, ideas and financial contributions that helped make 2022/23 a successful year. This work would not be possible without your support.




### Our mission.



## What you helped us accomplish this year.





#### **Outdoor fund becomes reality**

This year, we continued to advocate for a new outdoor recreation fund that will provide reliable and consistent access to grants for community-based volunteer groups, First Nations and local governments that support recreation-based projects throughout B.C. In September, we made a proposal to the province of B.C. for \$10M in seed funding, which came to fruition in spring 2023 when the Province gave ORCBC \$10M to set up an endowment and a granting program.

#### Showing the value of recreation

Research and data on outdoor recreation participation continue to be critical advocacy tools for us. ORCBC previously prepared a proposal to the Province for a comprehensive research study of participation and economic value, and in 2022 the Ministry of Environment and Climate Change Strategy announced that it is conducting a study with the results expected in summer 2023. ORCBC is concurrently working on a research report on the impact of outdoor recreation on rural communities, which through stories and quotes, illustrates the value of outdoor recreation.



#### More resources for outdoor recreation



Through our advocacy efforts over the past two years, nearly 4,000 British Columbians have shown their support for more investments in outdoor recreation. The province responded with increased budgets in Budget 2023 for BC Parks, Recreation Sites and Trails BC, forest service roads, active transportation and a \$100M Watershed Security Fund in Budget 2023.

#### New recreation strategy for BC

The Province announced that it's developing a new recreation strategy for BC. ORCBC is facilitating input from ORCBC's membership and helping to ensure that the organized recreation sector has meaningful opportunities to be heard.

#### **Climate change and recreation**



We worked with feature writer, Ryan Stuart, on a series of articles exploring the connection between climate change and recreation. Through conversations with scientists, advocates, land managers, recreationalists, and more, we looked at how a warming world and more extreme weather are impacting the activities we love and what practical efforts the recreation community is making to take action.

#### BC's most endangered river



In October, ORCBC and our Rivers Advisor Mark Angelo released the 30th annual BC Endangered Rivers list. While the 2021 list focused on the threats facing urban streams, this year's list focused on the Heart of the Fraser, one of the most ecologically significant stretches of river on the planet but also a part of the river that faces grave threats.



#### Working together in a good way

In October, ORCBC's Reconciliation Committee finalized a statement on how the committee and the ORCBC Board of Directors view our role in pursuing reconciliation with Indigenous Peoples. We recognize this is just the beginning of a long process, and we look forward to continuing this journey with our members. ORCBC also created a hub on our website featuring stories and resources to support relationship-building between Indigenous Peoples and recreation groups in pursuit of outdoor recreation initiatives.

We released two publications: The Citizen's Guide on Public Access to Crown Lands and Waters (UVIC Environmental Law Centre) and Best Practices for Developing Public Trails on Private Land. We also worked with a lawyer to conduct an analysis of the amendments to the Forest and Range Practices Act and how they may impact public outdoor recreation.

#### **Events**




ORCBC coordinated and promoted the second annual BC Trails Day celebration in June 2022. Forty-six communities from every region of the province hosted 54 local events, including clean-ups, recreational activities, trail stewardship projects and more. Thanks to donations and sponsorships, we were able to support 20 event host organizations with \$7,600 in micro-grants. In September, it was time to celebrate BC Rivers Day and World Rivers Day with 23 events registered on our website. Here in BC we had clean ups, paddles, festivals, planting events and more planned to celebrate rivers.
